2. Chair

Welcome to 2021. Last year was a year of transition, that although challenging, resulted in a fairly strong position for The Chamber. We are looking forward to a brighter year ahead and a return to normalcy. Leadership is important in good times and even more so in bad times. The board, staff and committees were thanked for demonstrating that leadership and volunteering their skills and time.

In 2021, COVID recovery remains the top issue, in particular for the tourism and hospitality sector. Having missed two back-to-back tourist seasons and they will have a longer recovery rate than most other sectors. The Chamber needs to make sure that those businesses are here for the recovery estimated to occur in the 2022 tourism season.

There has been a heavy personal toll on the mental health of the individuals in our community. Positive reinforcement providing help not stigmatism is needed. Many of the challenges in the downtown today have a foundation in unaddressed mental health problems. The Chamber will continue to advocate that resources beyond housing is needed to facilitate rehabilitation.

BC Chamber membership annual review went over the fundamentals of the decision in 2019. There were no fundamental changes in the value proposition of our membership with BC Chamber. A new CEO of the BC Chamber should be announced soon, during this transition,
