#### 3. Chair's Remarks

- a. The Chamber will be hosting a meeting with the Port Angeles Chamber in October. It will be a meeting between the Executives of each organization. The Chamber is also working with the Clipper to schedule a meeting with the Seattle Chamber.
- b. Family Business Association has voted to join The Chamber and transitions are in progress with a goal to wrap up the merger by end of June. The new Family Business Committee will begin in Fall of 2023.

#### 4. CEO's Remarks

Belleville Terminal announcement will happen later this week with funding from the Federal government as well as Provincial. South Island Chamber meetings and collaborations continue to be useful for business intelligence and positive collaborations. Work being done to connect two members – VIHA and Saunders Family Foundation on a community support project.

More work needs to be done to provide reliable, affordable, safe air travel for the region. Currently there are significant challenges related to delays and missed flights here on the island and beyond. There are currently 40 Indigenous Members participating in our Indigenous Economic Reconciliation Program. The Chamber has also worked collaboratively with GVHA, SIPP, CRD, City of Victoria and others to launch the South Island Business Directory to assist businesses to find Indigenous suppliers.

## 5. Committee Reports

a. Executive & Governance Committee

Discussion around the merger with FBA and how best to support and strengthen our commitment to family businesses in our region. Family Business representative to be appointed to the Board for a term of just over one year to provide continued guidance and support.
